Dear NSIP Member,

On behalf of the Center of the Nation National Sheep Improvement Program (NSIP) Sale Committee, I am inviting you to consign some of your best EPD sheep to this year's sale.

The fourth annual event will be held on Saturday, August 1, 2009 at the Clay County Fairgrounds in Spencer, IA, in the nation's livestock heartland, and will attract purebred and commercial breeders from across the country seeking quality rams and ewes. Polypays, Suffolks, Hampshires, Targhees, Dorsets, Columbias, Katahdins and other NSIP breeds are expected to be featured. With grain prices still high, the demand for superior EPD sheep is likely to be strong as buyers seek genetics that will gain more quickly and efficiently in less time on feed and produce outstanding offspring to add to their flock's bottom line.

This sale has become one of the hottest in the country and the only one exclusively selling sheep backed by the power of EPDs and entirely slick-shorn (excluding wool breeds & hair sheep).

This is your opportunity to showcase your flock's performance to an audience that values the genetic predictability of EPDs. We need your support of extremely high quality entries with progressive genetics to make this another successful event. To consign to this major event, we need your timely response to the following entry guidelines. **Please read carefully.**

1. Entry deadline for consignments and advertising is **June 20, 2009**. Please fill out the enclosed forms **completely**. All catalog information and photos must be in by this date so we are assured of prompt catalogs and effective advertising.
2. Entries are open to **all lambs and yearlings with NSIP EPDs**. Sheep will sell within their respective breed/age/sex group. Sale order for each breed will be determined by EPDs, for a truly objective, unbiased sale order.
3. It is recommended to limit your entries to 2 ram lambs, 2 yearling rams and 5 ewes of any combination of age (yearlings or younger).
4. Entry fees are **\$25.00 per head**. Check must accompany all entries, payable to Conover Auction Service.
5. Sale commission will be 10% of sale price in addition to the \$25 per head entry fee.
6. Sale expense will be charged on all "No Sales" at the price they leave the ring.
7. Signed sale agreement must also be returned to our office to comply with P&S regulations.

To help promote your flock you may also place an ad in the sale catalog. Please complete and return the enclosed form along with your payment to place your ad, along with your sale entries. **Note: All ads must be camera ready, if you need help to do this contact Conover Auction Service and we will assist you with setup for an additional fee. Ads placed in catalog will be at the discretion of the sale manager.**

2009 SALE RULES AND REGULATIONS

ARRIVAL: Consignments may arrive at the Clay County Fairgrounds Swine barn in Spencer, Iowa where the sale will be held starting at 1 p.m. on Saturday, August 1st and **MUST** be in place by Friday, July 31st at 3:00 pm, so sale orders can be determined Friday.

FAIRGROUNDS ADDRESS: The Clay County Fairgrounds is located at 1401 4th Ave W and the sale will be held in the Swine barn, located towards the center of the grounds. Enter at Gate E (on the SW corner of the grounds) off of 11th Ave W.

SALE HEADQUARTERS: AmericInn Hotel, Spencer, IA - (712) 262-7525. Ask for the “NSIP Sale Room Block” rate of \$89.00. A block of rooms has also been reserved at the Days Inn - (712) 580-4077. Ask for the “NSIP Sale Room Block” rate of \$85.00.

CHECK-IN: **Completed registration papers from the respective breed association must be presented to sale management at check-in time.** Animals not registered at sale time will not be eligible for the sale. Registration and health papers and any substitutions should be checked in with Conover Auction Service at the fairgrounds Swine Barn office by 4 p.m. on Friday, July 31st.

SPONSORSHIP: As sponsors of the sale, the Northwest Iowa Sheep Producers will receive an additional 1% of the gross sale price, deducted from each consignment to support promotional activities. In addition, the Iowa Sheep and Wool Promotion Board’s state checkoff of 10 cents per head will be taken to support industry promotion.

REGISTRATION PAPERS: All sheep consigned must have a valid registration paper from the recognized official breed registry, including all lambs sold at the dam’s side. Registration papers will be transferred by Conover Auction Service and forwarded to the buyers upon complete payment for the animal. The cost of transfers will be deducted from the consignor’s sale settlement. **All registration papers are to be signed and turned in to Conover Auction Service at check-in. No sheep will be sold or funds dispersed until registration papers are received by Conover Auction Service.**

HEALTH PAPERS: *All animals that sell must comply with Iowa and Federal health/scrapie requirements.* Call 866-USDA-TAG or the Iowa State Veterinarian’s office (515-281-5547) with questions. Consignors must provide two copies of a current valid health paper for each animal sold. Photocopies will be accepted in addition to the original. **A federal scrapie ID tag must in each animal’s ear.** This applies to sheep in all breeds and classes.

It is strongly recommended that rams over 6 months of age be tested for B-Ovis and negative test results be recorded on the health paper for each respective animal testing negative. Likewise, it is recommended that results of DNA at Codon 171 be listed for each respective animal tested, as a number of states require this for admission into their state. Taking the time to have these tests performed will help improve the marketability of your consignments.

All blackface rams (Suffolks, Hampshires or other blackface breeds) consigned and sold must include at least one “R” gene at Codon 171 to be eligible for the sale and Codon 171 results need to be indicated for each blackface ram offered. For example, blackface rams that are “RR” or “QR” at Codon 171 are eligible for the sale. Blackface rams “QQ” at Codon 171 are not eligible.

The following must be legibly written or typed on health papers:

- I. Owner/consignor name and address
- II. Species and purpose of movement (consigned to Center of the Nation NSIP sale)
- III. Private flock tag number
- IV. Federal scrapie ID number (must include premise ID and individual tag number)
- V. Age, sex and breed of each animal
- VI. Signature and printed name, address and phone number of accredited veterinarian.
- VII. Codon 171 DNA results for each blackface breed ram(s) consigned
- VIII. Negative B-ovis test confirmation for all rams over 6 months of age (strongly recommended)

As a consignor, it is your responsibility to insure that all required information is complete and legible. Please provide two copies of your health papers for each animal consigned.

SUBSTITUTIONS: Substitutions of sheep consigned to the sale are allowed, providing they meet the sale rules and regulations and health requirements. Any animal meeting the requirements may be substituted and do not have to be of the same sex or age as the original consignment.

SALE GUARANTEE: Entry of sale animals in this sale implies that the consignor agrees to the conditions set forth for this sale. The selling of any sheep in this sale constitutes a contract between the buyer and the seller. All consignors agree that all sheep are breeders. All lambs sold must maintain their lamb's teeth for 12 months from their date of birth, as recorded on the registration paper.

CALL/MAIL IN BIDS: Buyers unable to attend the sale may phone or mail in their bids to the Auction Service, Field Representatives or Auctioneer as listed in the catalog.

CREDIT VOUCHERS: Credit vouchers will be available from Conover Auction Service to verify settlements or credits consignors may need to extend to previous buyers. They must be signed by the consignor, the person receiving the credit and must include the date and dollar amount to be credited. This must be turned in to Conover Auction Service on sale day before the buyer settles for any sheep purchased in the sale.

PRE SALE SEMINAR: A free pre-sale seminar stressing how to use EPDs in your flock management will be held in the barn where consignments are featured on the fairgrounds on Saturday, August 1st beginning at 9:30 am.

LUNCH AVAILABLE ON GROUNDS: Enjoy a lamb lunch catered by the Northwest Iowa Sheep Producers on the fairgrounds sale day.

HELP PROMOTE THE SALE: Please provide the name, mailing address and e-mail addresses of prospective sale buyers and we'll see to it that they get the complete catalog for this year's exciting event. Advertising will also be placed in a variety of sheep and livestock publications reaching prospective buyers.
